Dear Chief Sullivan,

I would like to thank you again for allowing Sunbelt Fire the privilege of building the premiere fire apparatus in the industry for your department. We take great pride in helping our customers go above and beyond their goals.

It is my pleasure to inform you that your new fire apparatus is well on its way to being completed. As the delivery time approaches, I'd like to review a few items that will speed delivery and ensure a trouble-free transaction.

Since this is a cash transaction, our contract necessitates payment in full upon delivery and acceptance. The contract is in the amount of \$229,487.00 and is payable to Sunbelt Fire, Inc. You may choose one of the following payment plans:

- 1. If we deliver your unit to your fire department and acceptance is completed, please give the check to our Sunbelt Sales Representative or Delivery Representative.
- 2. In advance of delivery, you may forward the check by courier or a bank wire transaction at our expense.

Although your apparatus may still be approximately 45 days from delivery, we are aware that you may need to present the Invoice to your Board or Council well in advance of delivery in order to have payment ready at the time of delivery. It is for this reason that we are issuing the enclosed Invoice. This Invoice is not the Bill of Sale. You will receive a Bill of Sale at the time of delivery or soon thereafter (if issued by E-One).

Good business practice dictates that we not allow unpaid units to be delivered for two reasons:

Our insurance carrier has very strict requirements as to exactly what measures we must take to insure minimum exposure. Our dealer plate covers the apparatus while traveling from Ocala. Florida to Fairhope, Alabama and, if we deliver the unit, on to your station. When the unit is physically in your

fire station, it is out of our direct care, custody, and control, and as such, not covered by our insurance policy. At that time, our dealer-temporary plate must be removed from the vehicles and it becomes uninsured which is a liability that we are not in a position to assume.

Our second concern is the workman's compensation area of coverage. It is essential if your firefighters are being familiarized with the vehicle, the apparatus must be owned and insured by your buying authority. We do not provide any type workman's compensation coverage for your firefighters while being familiarized with the new apparatus. If a firefighter is injured during this session, serious legal questions could arise if any party other than the buying authority owned the vehicle and workman's compensation insurance was not provided.

Our Truck Administrator, Jan Jones, will contact you prior to delivery of the unit to verify payment is ready and to provide you with the Vehicle Identification Number, which you will need in order to obtain insurance. In closing, I hope your community will enjoy having this new fire apparatus and trust it will assist in saving lives and property. As always, we appreciate your friendship and business.
