On behalf of the above named client and pursuant to Mississippi Code Annotated Sec. 11-46-11 subsection I (Mississippi Tort Claims Act), I hereby tender Notice of Claim. Pursuant to the above referenced statute, I set forth the following information:

On or about September 30, 2016 at approximately 6:16 p.m., my client, Cameron Mazzoli (a minor) was walking up a driveway located at 6498 Road 318 Pass Christian, MS 39571. Suddenly, and without warning, while walking up the driveway, Miss Mazzoli was attacked by a brown / white pit bull mix dog that was not on a chain, and came out from a residence. The dog bit her once, and then let her go. Then, the dog came after her again, knocking her to the ground. The dog attacked her a 3rd time, injuring Miss Mazzoli even more. Harrison County Animal Control responded to the scene. Upon investigation, it was revealed to Miss Mazzoli and/or her family, that the Harrison County Animal Control had very recently (perhaps even the day before) come to the same residence for a complaint call on a dog. However, the animal control officer failed to abide by the County Ordinance stating that the dog must be "confined in a proper enclosure for a dangerous dog pending a resolution of the investigation or must be

Huntsville 256,539,85,00 surrendered to an animal control officer for immediate impoundment in the animal shelter. . ."

The animal control officer, both individually as well as in his/her capacity of her employment had a duty to Miss Mazzoli, as well as the community at large, and breached this duty in the following non-exclusive respects:

- a. By violating the Harrison County Animal Control Ordinance, section on "dangerous dogs", and thus allowing a dog that should have been classified as "dangerous" the ability to roam and injure members of the community, specifically Miss Mazzoli;
- b. By negligently hiring and/or supervising an employee of the Harrison County Animal Control;
- c. In violating the Revised Statutes of the State of Mississippi, all of which are pled as if copied herein in extenso; and
- d. All other acts of negligence which were the cause of the collision sued upon and will be shown at the trial of this matter.

As a result thereto, Miss Mazzoli suffered serious bodily injuries to both arms, both legs, her head, and serious psychological issues for which damages are sought herein. Said damages include but are not limited to the following as may be shown by a preponderance of the evidence: past and future medical expenses, past and future pain and suffering and loss of enjoyment of life, past and future loss of wages and wage earning capacity, as well as past and future mental and emotional damages.

Miss Mazzoli would show that at all relevant time herein, Donald Necaise was an employee, agent or assign of Harrison County Animal Control, so as to invoke responded superior. In the alternative, Mr. Necaise was an officer with the Harrison County Sheriff's Department, and acted in reckless disregard by failing to secure a potentially dangerous dog. In this role with the Sheriff's Department, responded superior would be invoked.

Miss Mazzoli is aware only aware of those individuals stated on the incident report (attached hereto) as having knowledge or information concerning the accident facts.

Miss Mazzoli seeks monetary damages in an amount to coincide with Miss. Code Ann. § 65:162 of \$500,000, or any amount greater or lessor to be determined by the trier of fact.

At the time of the accident and at present, the claimant resides at 57096 Allen Road in Slidell, Louisiana 70461.

All inquiries concerning this claim are to be made to my office at the above address. I expect to file suit under the provisions of Mississippi Code Annotated §11-46-11, et seq., after the expiration of the ninety day limitation. Please contact me if you have any questions, comments or concerns.

On Friday September 30, 2016 at approximately 1834 hours, Deputy Donald Necaise responded to the above listed address in reference to an animal problem a dog bite. Deputy Necaise spoke to a Cameron Mazzoli who stated she had came to visit with her friend. Cameron Mazzoli stated her friends driveway is rough to drive up and she was in her mother's car, so instead of driving her mother's car up the drive she parked it at the end of her friends driveway and got out to walk to her friends house. Cameron Mazzoli stated when she went walking up the driveway a brown / white pit bull mix dog came out from the residence in front of

her friends house. Cameron Mazzoli stated she felt when the dog bit her and let go, so she thought OK then If I can just get into her friends house . Cameron Mazzoli stated that is when the dog came after her again knocking her to the ground and all she could think to do is to kick the dog. Cameron Mazzoli stated that and old black male came out in a wheel chair. Cameron Mazzoli stated the black male started yelling the dogs name and it was only upon the third time the man called the dogs name did he stop its attack on her. Cameron Mazzoli stated that when she took her chance to get up and to get in side her friends house. Cameron Mazzoli stated it is the only dog not on a chain. American Medical Respond arrived on scene and transported Cameron Mazzoli to Memorial Hospital at Guilfport Emergency Room, Cameron Amazons had laceration on her right / left arms , on her right/ left legs and to the top of her head . Deputy Necaise located the dog a fawn / white male terrier, pit bull mix dog. Deputy Necaise had the owners family to get in touch with him by phone and tell him to come to the location . Deputy Necaise made contact with the owner a Terry Dedeaux. Deputy Necaise explained the complaint to Terry Dedeaux. Deputy Necaise explained that Animal Control will be taking custody of his dog for ten day quarantine . Deputy Necaise took custody of a fawn / white male terrier pit bull mix dog named King . Deputy Necaise transported the pit bull mix dog to the Humane Society for ten day quarantine.

On Sunday October 01, 2016 at approximately 1050 hours, Deputy Donald Necaise received a text from Tiffany Mazzoli the mother of Cameron Mazzoli. Tiffany Mazzoli advised Deputy Necaise that Cameron Mazzoli had to get 55 total body stitches and 10 scalp staples. Tiffany Mazzoli stated that Cameron Mazzoli is in a lot of pain. Tiffany Mazzoli email photo's of her daughter's injuries. (see attached photo's)
