# ORDER APPROVING REINSTATEMENT OF HOMESTEAD EXEMPTION FOR TAX PARCEL 0712D-03-023.000 FOR THE 2015 TAX YEAR

WHEREAS, Tax Parcel No. 0712D-03-023.000 was assessed to Larry and Juliet Arnold on the 2015 assessment roll; and

WHEREAS, the property owners filed a Mississippi Homestead Application in Harrison County seeking homestead exemption for said parcel for the tax year 2015, (the "Harrison County Exemption"); and

WHEREAS, the property owners had previously filed for and were granted a Mississippi homestead exemption for property located in Simpson County, Mississippi, (the "Simpson County Exemption"); and

WHEREAS, the property owners' homestead designation for their Simpson County property was not removed prior to their filing of the Harrison County Exemption; and

WHEREAS, state law prohibits property owners from claiming more than one (1) homestead exemption; and

WHEREAS, as a result of property owners' Simpson County Exemption, the property owners' Harrison County Exemption for the 2015 tax year was denied; and

WHEREAS, the Simpson County Exemption has been rescinded and the property owners have requested that the Board of Supervisors reinstate the Harrison County Exemption for the 2015 tax year for Tax Parcel No. 0712D-03-023.000; and

WHEREAS, the Board of Supervisors of Harrison County, Mississippi finds that in the absence of a valid homestead exemption claim elsewhere, the property owners are entitled to homestead exemption for Tax Parcel No. 0712D-03-023.000 for the 2015 tax year.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF SUPERVISORS OF HARRISON COUNTY, MISSISSIPPI, AS FOLLOWS:

SECTION I. The findings, conclusions and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

SECTION II. Upon adoption of this Order, the Board of Supervisors of Harrison County, Mississippi, finds and adjudicates that homestead exemption should be reinstated for Tax Parcel 0712D-03-023.000 for the 2015 tax year.
