WHEREAS, the Harrison County Board of Supervisors has determined that the property owned by Todd J. Babin, 3957 Grilletta Court, Marrero, Louisiana 70072, located at 19141 West Wortham Road, Saucier, Mississippi 39574, and being more particularly identified as Parcel No. 0604N-01-008.123, is in such a state of uncleanliness as to be a menace to the public health, safety and the community; and

WHEREAS, the Board finds that a hearing should be held on the 7th day of August, 2017, at 10:00 a.m. in the Board of Supervisors Meeting Room, Harrison County Courthouse, First Judicial District, 1801 23rd Avenue, Gulfport, Mississippi 39501 to adjudicate whether said property is in such a state of uncleanliness as to be a menace to the public health, safety and the community; and

WHEREAS, notice of said hearing shall be sent by United States mail to Todd J. Babin, owner of the subject property, at 3957 Grilletta Court, Marrero, Louisiana 70072 and at 19141 West Wortham Road, Saucier, Mississippi 39574; and

WHEREAS, notice of said hearing shall be posted on the property located at 19141 West Wortham Road, Saucier, Mississippi 39574, being more particularly identified as Parcel No. 0604N-01-008.123, and at the Harrison County Courthouse, First Judicial District, 1801 23rd Avenue, Gulfport, Mississippi 39501. A copy of said Notice is attached hereto as Exhibit "A" and incorporated herein by reference; and

WHEREAS, if the Board of Supervisors, after a hearing on the matter, adjudicates that said property is in such a state of uncleanliness as to be a menace to the public health, safety and the community, the Board of Supervisors may, if the owner does not do so himself, proceed to have the land

cleaned by cutting weeds, filling cisterns, and removing rubbish, dilapidated fences, outside toilets, dilapidated buildings and other debris, and draining cesspools and standing water. Thereafter, the Board of Supervisors may at its next regular meeting by resolution adjudicate the actual cost of cleaning the land and may also impose a penalty not to exceed One Thousand Five Hundred Dollars (\$1,500.00) or fifty percent (50%) of the actual cost, whichever is more. The cost and any penalty shall become an assessment against the property; and

WHEREAS, the County may reenter the property or parcel of land to maintain cleanliness without further notice of hearing no more than six (6) times in any twelve-month period with respect to removing dilapidated buildings, dilapidated fences and outside toilets, and no more than twelve (12) items in any twenty-four (24) month period with respect to cutting grass and weeds and removing rubbish, personal property and other debris on the land. The expense of cleaning the property shall not exceed an aggregate amount of Twenty Thousand Dollars (\$20,000.00) per year, or the fair market value of the property subsequent to cleaning, whichever is less. The Board of Supervisors may assess the same penalty each time the property or land is cleaned.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF SUPERVISORS OF HARRISON COUNTY, MISSISSIPPI, AS FOLLOWS:

SECTION I. The findings, conclusions and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

SECTION II. Upon adoption of this Order, a public hearing shall be held on the 7th day of August, 2017, at 10:00 a.m. in the Board of Supervisors Meeting Room, Harrison County Courthouse, First Judicial District, 1801 23rd Avenue, Gulfport, Mississippi 39501to consider whether or not the property owned by Todd J. Babin, 3957 Grilletta Court, Marrero, Louisiana 70072, located at 19141 West Wortham Road, Saucier, Mississippi 39574, and being more particularly identified as Parcel No. 0604N-01-008.123, is in such a state of uncleanliness as to be a menace to the public health, safety and the community requiring that it be cleaned, with the cost of same being assessed as a lien against the property in an amount not to exceed \$20,000.00 per year.

SECTION III. That a notice of this public hearing shall be posted on the property located at 19141 West Wortham Road, Saucier, Mississippi 39574, and being more particularly identified as Parcel No. 0604N-01-008.123, and at the Harrison County Courthouse, First Judicial District, 1801 23rd Avenue, Gulfport, Mississippi 39501. Further, said notice shall be sent by United States mail to Todd J. Babin at 3957 Grilletta Court, Marrero, Louisiana 70072 and 19141 West Wortham Road, Saucier, Mississippi 39574 advising him of this hearing and that he will have an opportunity to appear and present evidence as he may see fit.
