

Supervisor **BEVERLY MARTIN** moved the adoption of the following Order:

**ORDER APPROVING OUR LADY OF FATIMA’S USE OF COUNTY EQUIPMENT**

**WHEREAS**, Ashley Ross, President of Our Lady of Fatima Elementary School PTO, sent a letter to the Harrison County requesting the temporary use of the County’s wooden stage at Our Lady of Fatima Elementary School’s Annual Halloween Carnival on October 21, 2017. A copy of said letter is attached hereto as Exhibit “A”; and

**WHEREAS**, Harrison County desires to cooperate with Our Lady of Fatima Elementary School by allowing its stage to be used during the carnival; and

**WHEREAS**, use of the stage by Our Lady of Fatima Elementary School combined with signage posted at the event will provide Harrison County an avenue by which it can favorably advertise the opportunities, possibilities and resources that exist within Harrison County as provided by Miss. Code Ann. § 17-3-1 (1972), as amended.

**NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF SUPERVISORS OF HARRISON COUNTY, MISSISSIPPI, AS FOLLOWS:**

**SECTION I.** The findings, conclusions and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

**SECTION II.** Pursuant to the provisions of Miss. Code Ann. § 17-3-1 (1972), as amended, Our Lady of Fatima Elementary School’s request to use Harrison County’s wooden stage at the school’s Annual Halloween Carnival on October 21, 2017, be and hereby is approved.
